

Data processing security regulations for the endurance hike BK KOLKA ← DUBULTI [136km 55h] 2024

The endurance hike BK KOLKA ← DUBULTI [136km 55h] 2024 is organized by the association “Baltā Kalna Komanda” (hereinafter referred to as the Organizer), reg. No. 40008210102, legal address Rīga, Līves iela 18 - 2, LV-1002, email info@baltaisikalns.lv.

Personal data is collected to ensure the participation of the participants and the compilation of the results on the hike's website www.kolkadubulti.lv.

Please carefully read the data processing security regulations to understand why the data is collected and how it is used.

The Organizers collect the following personal data:

- Name;
- Surname;
- Gender;
- Date of birth;
- Email;
- Contact phone number;
- Occupation;
- Area of residence;
- Time spent on the hike.

By registering for the hike, the participant agrees to the processing of their personal data for the purposes of organizing the hike. To ensure the objectivity of the hike results, it is necessary to provide the participant's name and surname.

Other data, such as occupation and residential address, are provided at the participant's discretion and are used for statistical purposes and future event planning.

In order to ensure the safety of participants during the hike, as well as for informative communication, the contact phone number and email of each participant are collected.

By selecting the appropriate checkbox on the registration form, the participant gives consent for their email to be included in the Organizers' news database, the purpose of which is to inform participants about other events. At any time, the participant has the option to unsubscribe from receiving newsletters by writing to info@baltaisikalns.lv.

The participant's name, surname, and time between campsites are visible in the results published on the website www.kolkadubulti.lv. If the participant does not wish to be listed publicly, they must inform the Organizer by

writing to the email info@baltaisikalns.lv. In this case, only the participant's number will be displayed in the publicly available results.

Data processing objectives:

- Processing of participant applications;
- Publication and registration of participant results;
- Creation of personalized hike cards for participants;
- Operational communication with hike participants;
- Statistical purposes and future event planning.

By registering for the hike, the participant confirms their free will to participate in the hike and agrees to the terms of participation and the processing of their personal data, observing the scope, purpose, and term set out in these security regulations.

The participant is informed that during the endurance hike, they will be recorded in audio, audiovisual, and visual art works (photos, videos) for promotional and informational purposes.

Data retention period

The Organizers will store the participant's data for as long as necessary to:

- Carry out the endurance hike event;
- Comply with the requirements of European Union/Latvian Republic legislation.

Data disclosure

The Organizers may disclose the participant's data to third parties in cases where it is necessary for the organization of the hike or when required by law, including but not limited to:

- An insurance company in the event of a claim against the Organizers for professional liability insurance;
- A law firm providing legal assistance to the Organizers in cases of defense of the Organizers' interests;
- Law enforcement authorities in cases specified by law;
- To a limited extent (participant's name, surname) made available to the Organizers' cooperation partner SIA R.A.SERVISS (Virsošne store) for the purpose of verifying the participant's status in a discount campaign organized by them.

The Organizers will not disclose the participant's data to third parties for marketing purposes.

Access to and correction of data

You have the right to request information about yourself that is in the possession of the Organizers, as well as the right to request the deletion or correction of data concerning you in the possession of the Organizers.
